Program:

Veterinary check, corrections **7:00 – 9:00**, judging + special shows, BIC, BIS, BOB **10:00 – 18:00 / 19:00**, the closing of the show. Chairs will not be available. Refreshments can be bought at the venue in the canteen.

Show rules are in compliance with ČSČH-SCHK regulations. Exhibitors may present their cats to the judges themselves. Stewards will be available during the whole show. Exhibitors participate in the show at their own risk. The organizer is not liable for any damages incurred during the show.

Leaving the show before its closing is allowed only with the written consent of the show committee.

Cats of exhibitors from other (non FIFe) organizations can enter classes 9 - 12.

Veterinary rules: The cats have been vaccinated by a veterinary surgeon in accordance with each country's veterinary regulations, against feline panleucopenia, feline calicivirus and feline herpesvirus, and have had the required boosters, at least 15 days prior to the show. The period of the validity for the vaccination is marked by the veterinary surgeon in the pet passport or on the vaccination certificate. Vaccination against rabies is to be according to national legislation - all cats living outside of the Czech Republic must be vaccinated against Rabies. White cats must have a certificate stating that they are not deaf.

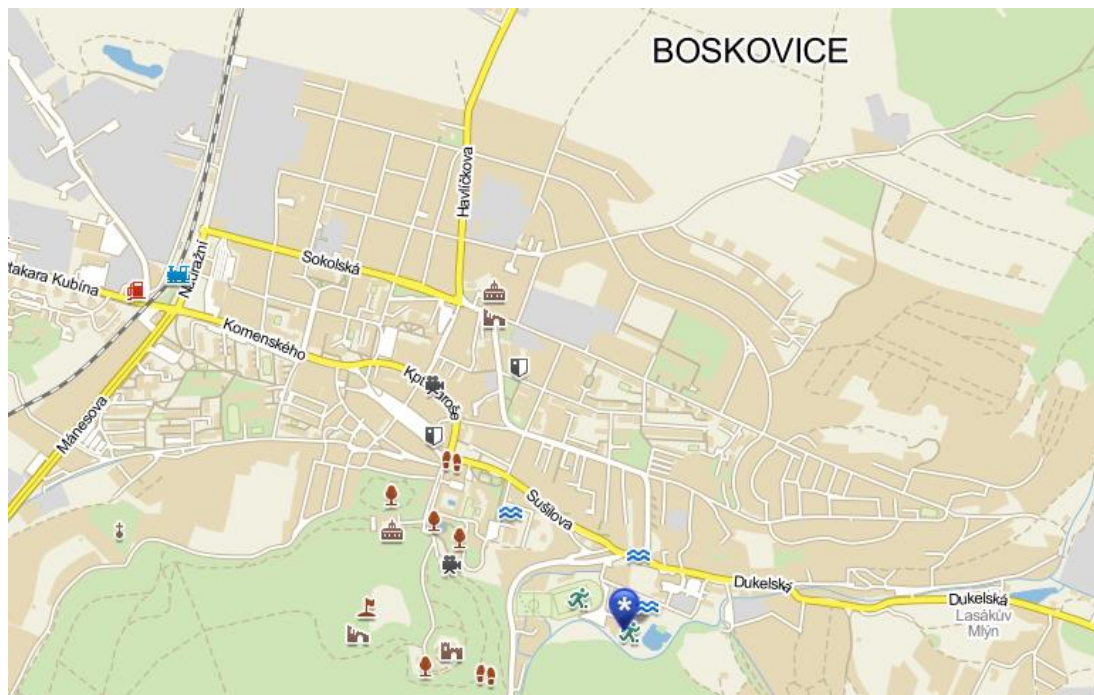
