### **Informations for exhibitors:**

Show cages - modern metal, self-supporting structures with dimensions 70x70x70cm and fixed flooring. **The chairs are available.** Restaurant near the building is available. **Cages are not numbered!** Earlier edition of review is charged 10 € one review. Unpaid and unapproved advertising and sales on cages are prohibited.

**Show rules:** are according to the rules of ČSCH-SCHK (FIFe). Exhibitors may present their cats to the judges personally. Stewards will be available. Participation at the show is on your own risk, requirements for refundation will not be accepted. Early leaves from the show are available only with the permission from the director of the show. You can cancel your entry only by the closing date. NON FIFe members can also exhibit at the show, in classes 9-12.

**Veterinary rules:** The cats have been vaccinated by a veterinary surgeon against feline panleucopenia, feline calici virus and feline herpes virus, and have had the required boosters, at least 15 days prior to the show. The period of validity for the vaccination is marked by the veterinary surgeon in the pet passport or on the vaccination certificate. Vaccination against rabies is to be according to national legislation - all cats living outside of the Czech Republic must be vaccinated against rabies. The owners of white cats must have a veterinary certificate stating that the cat is not deaf.
