### Show rules:

Exhibitors may present the cats to the judges themselves, stewards will be at their disposition. Participation is at the risk of the exhibitor; requirements for refundation will not be accepted. Chairs will be available, cages are not numbered. Please indicate your own cages in the application form. Earlier leaving show will be accepted only with permission of show director. Non FIFe exhibitors are welcome, They have to accept FIFe show rules. You will get confirmation about acceptance your entries by email.

**Veterinary rules:** The cats have been vaccinated by a veterinarian in accordance with each country's veterinary regulations against feline panleucopenia, feline calicivirus and feline herpesvirus, and have had the required boosters, at least 15 days prior to the show. The period of the validity for the vaccination is marked by the veterinarian in the pet passport or on the vaccination certificate. Vaccination against rabies is to be according to national legislation –all cats living outside of the Czech Republic must be vaccinated against rabies. White cats must have a certificate stating that they are not deaf.
