If you show a breed judged in groups you must indicate the full EMS code and the group number ! (ACL/ACS, MCO, NEM, NFO, SIB, TUA, BML, CRX, DSP, DRX, GRX, KBL/KBS, PEB or SPH).

We do not require a stamped entry form; the secretary of your club will get an e-mail request from us to confirm your membership and the details of your cats.

Entry forms sent after closing date, without payment, or without confirmation of your membership can be rejected.



All exhibitors must pay the show entry fees before closing day to the bank account. All fees have to be paid in Euro.

Entry forms sent after 24.04.2019 : + 10 € / cat

Third and any other cat of the same exhibitors registered for both days - show fee only 30 € / 2 days

Litter = 3 kittens in double cage + reports for all kittens (8 reports in total) = 130 € / 2 days

Show rules:

- exhibitors or persons authorized by them may present the cat to the judges themselves, a steward will always be at their disposition
- cage order by exhibitor's last name (ABC). No changes in cage order are possible.
- cats must stay in their decorated cages until the end of the show.
- it is not allowed to remove cats from the show hall before the scheduled end-time without special permission from the secretariat
- participation is at risk of the exhibitor, no claims for damages will be accepted.
- all changes in classes must be announced to the show secretariat until 9:30 am.
- all FIFe show rules are valid and applicable.

Veterinary rules:

All cats have been vaccinated by a veterinary surgeon in accordance with each country's veterinary regulations against feline panleucopenia, feline calicivirus and feline herpesvirus, and have had the required boosters, at least 15 days prior to the show. The period of the validity for the vaccination is marked by the veterinary surgeon in the pet passport or on the vaccination certificate. Vaccination against rabies is to be according to national legislation – all cats living outside of the Czech Republic must be vaccinated against rabies. White cats must have a certificate stating that they are not deaf.
